

New Water Rates (Effective with water bills mailed January 1, 2017)

A rate increase of 5% was approved by the Otay Water District Board of Directors.
This increase will be reflected in your January billing statement.

The new water rates* are as follows:

An analysis of the District's costs and revenues indicates an average 5% rate increase is needed for water services billed on or after March 2017 and may apply to water used as early as the beginning of March 2017 . The rate increase will pass-through increases implemented by the District's water wholesalers (MWD and CWA) and will allow the District to recover other increases in operational costs.
